AIRPORT AND GOVERNMENTAL AFFAIRS

Governmental Affairs & Grants

The scheduled meetings with our Federal Congressional Delegation went well on March 7, 2024, in Washington, D.C. City leadership was able to convey top Federal priorities as well as hear the top priorities of each of our College Park representatives,

Senators Raphael Warnock & Jon Ossoff, Congresswoman Williams Nikema Congressman David Scott. A special thanks to the team input, leadership, and commitment to making College Park a world class place to live, work and play! Follow up with each elected office has been completed and further conversations with the appropriate office staff is the start of a productive relationship to bridge the gap on specific grant opportunities for our projects and to garner appropriate letters of support for grant applications, etc.



In more great news... The Consolidated Appropriations Act for 2024 was signed into law



this past week. This allowed for the funding of two specific College Park projects: Water Supply Project (Water System Improvements Project – water tank and pump) in the amount of \$959,752 and Finding the Flint Nature Preserve for \$500,000. College Park IS winning!! In order to keep winning, College Park must continue to apply for earmarked funding and grants opportunities, as the next phase of the federal priorities process commences. Next week, **Airport** Governmental Affairs and our federal lobbvists

will prepare earmarked funding for the lead pipe replacement in areas throughout the City, as well as Camp Truitt property improvements. Other priorities which can be handled via regional, or state grants will be pursued in the coming weeks.

Georgia's 2024 electoral race surged ahead this past week with the commencement of qualifying procedures for state and federal positions. A multitude of candidates representing both the Republican and Democratic parties flocked to the state Capitol to complete paperwork and submit qualifying fees. Concurrently, contenders vying for nonpartisan roles and running as independents queued up across the street to complete their qualifying process at the Secretary of State's office. The deadline for candidates to officially enter the race is set for noon on Friday.

Although the presidential race will dominate Georgia's November ballots, attention is also focused on all 14 of the state's congressional seats, along with its 56 state Senate seats and 180 state House seats, which are up for contention. Primary elections are slated for May 21, the same day Georgia will cast votes for judges and various nonpartisan positions. Subsequently, runoff elections are scheduled for June 18 to resolve any contests where a candidate fails to secure a majority of votes on May 21.

At the end of the fourth qualifying day, March 7th, 92 candidates qualified to run for a State Senate seat, and 306 candidates qualified to run for a State House seat. Please note that this information is on candidates qualifying Thursday and before. Updated qualifying information will be sent shortly upon the availability of additional data.

During the Senate Public Safety and Criminal Justice Appropriations meeting, various departments discussed budgetary adjustments and allocations. Georgia Emergency Management and Homeland Security highlighted increases for data operation centers. GPSTC proposed state-wide changes, including curriculum specialist and mechanic hires, alongside full-year CPR funding and construction of training facilities. POSTC supported the governor's budget, advocating for salary enhancements for officers, GA Post Reliance programs, curriculum monitoring, and additional staff hires for investigative and training programs. Other departments, such as the Department of Public Safety, also voiced support for increased funding, particularly for career progression, operational expenses, and capital projects. Others like the Department of Pardons and Paroles and the Department of Juvenile Justice outlined requests for software, salary adjustments, and facility maintenance, among others. Additionally, CJCC sought funds for victim services, while the GBI proposed funding increases for crime lab personnel and equipment.

Airport Affairs & Community Outreach

On March 13, 2024, the City of Atlanta, Transportation Committee approved that a substitute be brought forth at a later date based on the request to name Concourse D, located at Hartsfield-Jackson Atlanta International Airport, to Michael R. Hollis. Concourse D is a multi-million dollar expansion and upgrade project, currently underway.

Airport & Governmental Affairs is working with Hartsfield-Jackson Atlanta International Airport and College Park Public Works Dept. regarding the water system repairs at the Atlanta Fire & Rescue Department on Clipper Drive, which are scheduled to be completed by the end next week. Additionally, with ATL's Real Estate team, we are addressing six (6) properties to be conveyed to the City of College Park. To resolve this, the ATL staff is taking this matter before the Atlanta City Council tentatively in May 2024.

Please be advised that the MARTA Airport Station, located at 3800 Main Street, Atlanta, will be closed for renovation beginning Monday, April 8, 2023 – Sunday, May 19, 2024. Shuttle buses will replace trains from College Park Station & North Terminal Lower Level. Please go on-line to learn more at MARTA (itsmarta.com).

iVue Robotics, Safran, just to name a few. College Park was also a participant.

Airport will participate in the Career Day for The Main Street Academy, charter K-8 elementary school on March 14, 2024. These efforts help the Atlanta region support the aerospace, transportation, and



logistics industries, etc. to strengthen our global City's economy.

Ongoing Education




Backups Limited Information

POLICE DEPARTMENT

Background Recruitment

In our continued efforts to recruit the College Park Police Department, Command Staff along with other members of the police department held a hiring board on March 6, 2024.

The board recommended two (2) Certified Police Officers, a noncertified Police Officer, and a Jailer for hire. These individuals will undergo an intensive background check. Once they meet all background and hiring guidelines, we look forward to them joining the College Park Police Department Family. [Strategic Connection: Public Safety and Security]

Community Outreach

On Friday, March 8, 2024, members of College Park Police Department assisted the Fulton County Board of Health with an inspection detail at the Travelodge hotel, located at 2471 Old National Pkwy.

The Travelodge hotel consists of two buildings on the property with a total of 104 rooms. More than ninety percent of the rooms were occupied with guests. The range of stay varied from 1 day of stay to more than 30 days of stay (months).

During the inspection numerous violations were identified within each hotel room. Some of the violations consist of roaches, bugs, leaks, faulty leaks, water stains in ceiling, peeling paint, warming plates, microwaves, faulty bathroom conditions, fire hazards, missing smoke detectors, etc.

Police observed rooms in deplorable condition. Foul odors and unkept living arrangements. Rooms were occupied by several occupants to include several children, ages ranging from infant to 15 years of age. Some of the children advised they were not in school. Several notations were made for a Georgia Division of Family & Children Services (DFCS) follow up.

The Board of Health detail coordinator will initiate the notification process directed at the Travelodge manager, who will then have a grace period of thirty days to address the issues, particularly pertaining to odors, bugs, mold, and mildew.

Failure to rectify the identified problems within the specified timeframe may result in the hotel's closure. A full report of today's findings will be requested from the Board of Health. Additionally, numerous citations were issued to the manager/owner of the Travelodge Hotel. [Strategic Connection: Public Safety and Security, Quality of Life]







Public Safety

1777 Harvard Ave (The Pad Apartments), *Aggravated Assault/Strongarm-Robbery/Damage to Property*, A Male and female were involved in a verbal dispute over money. The male subject became irate. The male subject physically assaulted the female and damaged the female subject vehicle using a hammer. After physically assaulting the female subject, the male snatched the female purse without her consent; one subject taken into custody.

5110 Old National Hwy (Chevron), *Suspicious Person*, College Park Police Officer, while conducting patrols along the Old National Highway and Godby Rd corridor observed a male loitering in front of the gas station, after making contact with the male in was discovered he was in possession of methamphetamine: one subject taken into custody.

2505 Godby Rd, *Hit and Run Accident*, Our Crime Analyst was able to locate a suspect vehicle through FLOCK. With this information, one of the College Park Police Department's Accident Investigators was able to locate the registered owner's home in East Point and make contact. The vehicle in question was present at the home and had visible damage. The owner/driver confessed to driving the vehicle at the time of the accident; one subject was taken into custody.

Staffing

Highway, Streets and Storm Water

Recently, the Highway, Streets and Storm Water department has been actively addressing the impact of heavy rainfall in our city. This persistent rain has resulted in several infrastructure challenges, including the emergence of potholes, sinkholes, and drainage issues. To better manage these on-going concerns, the department is utilizing CCTV technology to gather essential data.

Additionally, the department has undertaken several other initiatives, from curb repair on Colonial Drive, sidewalk repair on Virginia Avenue, installation of a street sign on Herschel Road and Riverdale Road, installation of an RPM on Lakeshore Drive from Herschel Road to Janice Drive to sinkhole repair on Lakeshore drive.

During the sinkhole repair, the team applied additional GAB into the hole for repacking.
