



# Funding Plan for 2024 Federal Agenda

College Park elected officials and staff have identified priority projects to be included in the city’s Federal Agenda. In FY 2025 appropriations, Representatives David Scott and Nikema Williams can each advance a total of 15 projects to the appropriations committee.

Below is a list of the priority projects, possible funding sources, congressional district, and funding details for the earmark account to help city officials determine the projects to submit in the FY 2025 appropriations cycle.

Note, Rep. Scott’s submission deadline is March 25 (and he will only accept two projects per jurisdiction); Sen. Warnock’s deadline is March 22; and we expect the other two offices to set deadlines around the same time.

## Road Noise

1. Explore funding opportunities to construct sound walls/noise barriers to deflect interstate noise and improve quality of life for area residents.
  - *Possible earmark opportunity in partnership with Hapeville and East Point.*
